 - o Tu Casa Attorney Letter Code requirement all 30 units have the ability to add solar.
 - Overview How to make solar available to all 30 units.
 - o Solar Proposition Explain the difference in choosing to do solar now vs after April 13th.
- Approx cost will be \$20,000 per unit for a 5 KW system 480 watt solar panel (details to follow).
- Comprehensive Zoom Meeting for all homeowners on March 7, 2023 from 6:30pm to 8:00pm.
- Collect proposals from 2 different companies by March 10, 2023.
- Deadline for homeowner decision regarding purchase. Each homeowner will need to sign either their
 acceptance to commit to solar now or sign confirming they decline to be a part of solar installation at
 this time. This will be explained further in the Zoom meeting.
- Contracts must be signed prior to April 13th deadline. Installation to be completed as early as feasible.
