#### **Pool Heat**

After review of a pool survey sent out early 2019, the Board approved heating the pool from April 1 to October 31, estimating an average savings of \$168 per year per unit. The pool heat was turned off December 23<sup>rd</sup>. We apologize for not sending a reminder in advance.

The Board is working with our new management company to create a maintenance matrix for routine scheduling planned items such as this and other maintenance items, like proactively jetting common area drains.
