A new gate is in the process of being installed by the boat docks. 24 new entry lights have been purchased for owners and the Board will approve having those installed on the 1st, 2nd, and 3rd floor. Two landscape valves to make sure the lawn is not getting over-saturated were installed.

**Architectural** - Kirk Cowles reported the committee requested direction from the Board of top priority projects for them to work on and the Board agreed on making the paver project the top priority.

### **UNFINISHED BUSINESS:**

RESOLVED; to approve the bid from John Quartz in the amount of \$1,080 to install the light fixtures. The Board also agreed (based on prior agreement) to reimburse \$75 to the 4<sup>th</sup> floor owners (Units 25-30) who previously bought and installed, on their own, the Common Area entry light fixtures.

### **NEW BUSINESS:**

**Safe reopening plan -** Per the new Red Tier safe reopening guidelines implemented by the State, the Board agreed:

- To open the Pool with a maximum 3 families at a time
- To open the Rec Room with a maximum 3 families at a time
- To open the BBQ with a maximum 1 family at a time
- The Spa will remain open with a maximum 1 family at a time
- The Sauna must remain closed

Linda Shafer will post the new Safe Reopening Plan on the Bulletin Board and on the Rec Room windows and will announce in a Newsletter.

Bid to grind concrete areas - Upon a Motion made by Linda Shafer, seconded by Kirk Cowles and carried, it was:

RESOLVED; to approve the bid from Handyman Dan to grind several lifted concrete areas in the community, as long as the cost does not exceed \$700.

**Bid for pavers at two entries -** The Board decided to wait on the paver bids until the Architectural Committee agrees to a plan for the driveways.
