# We have a new Club House / Recreation Room Reservation System

Note that Tu Casa Recreation Room/Clubhouse reservations are not confirmed until the owner is notified via e-mail by management and the event is listed on the Recreation Room/Clubhouse Calendar posted on the tucsasahoa.org website and on the lobby Bulletin Board. If you have a cancelation, please email

aupchurch@propadvantage.com at your earliest convenience in respect of others. Tenants may reserve the Recreation Room/Clubhouse by contacting their landlord to make the reservation on their behalf. The landlord/homeowner will be liable for any charges or damages exceeding the deposit.

Once our Property Manager receives an accurately completed reservation request, she will send the form to the Recreation Room/Clubhouse Rules Sub-Committee to schedule with the homeowner and/or Tenant a pre and post party inspection and she will email to Linda Shafer to post the updated reservation on the website and lobby bulletin board calendars.
