### These are extremely trying times

The COVID-19 situation has completely changed Tu Casa's priorities for the year. We are a small community and your Board is dedicated to working together to help our membership and residents through these hard times. We are sending this Newsletter to help keep you informed and advise of changes agreed to during emergency Executive Session Meetings.

# Monthly homeowner assessments

All homeowners should have received notice of the Board's decision to place a 3-month moratorium (April, May and June) on Tu Casa Homeowner Assessments. This was possible due to a healthy reserve balance, but is a roughly \$60,000 hit to our Tu Casa budget that we will re-assess in better economic times.

### All non-essential projects on hold

Regular maintenance of our property will continue, but all non-essential projects are on hold. This decision was made due to the Board's concern with exposing our residents to unnecessary outside contractors and our concern with committing any additional Tu Casa funds to non-essential projects until our economy has turned around.

### Pool, Spa, Sauna, Rec Room and BBQ all closed

In line with State and County regulations, these areas are completely closed and pool and spa heater will remain off until further notice. Additionally, the board will continue to pursue efforts to secure the pool area so non-residents will not be able to reach over gates to gain entry.
